

Sasfin Wealth - Cristal Challenge 2024 – Terms and Conditions

Sasfin Wealth Cristal Challenge is a stock pick challenge where entrants pick the 5 JSE shares they believe will perform well throughout the duration of the challenge.

Duration of the challenge:

1. The challenge will run from 1 February 2024 to 31 October 2024

Who may enter the challenge:

- 2. The challenge is open to anyone over the age of 18 years.
- 3. Participants from any jurisdiction are eligible to enter the challenge.

How to enter the challenge:

- 4. Each participant must select five shares currently listed on the Johannesburg Stock Exchange. Click <u>here</u> to find the list of companies. The participant is allowed to cash-in one of their investments during the year.
- 5. Participants should click <u>here</u> and complete the registration form, where they will indicate their 5 selected shares. This link will be shared with prospective participants via email, Sasfin's social media channels (LinkedIn & Twitter), the Sasfin Wealth Content Hub and David Shapiro's LinkedIn page.
- 6. This link will be shared with prospective participants from 12 January 2024. Entries will close at midnight on 31 January 2024.

How many times can a participant enter:

7. Each participant can only enter once.

Categories of the challenge:

- 8. There will be 3 categories in this challenge:
- 8.1 Student: Participant between the ages of 18 -21 who is currently a student at a tertiary education provider in South Africa
- 8.2 Non-Professional: Anyone who is older than 21 and who is not working as an investment professional.
- 8.3 Professional: Anyone older than 21 who works as an investment professional.

Requirements participant must meet to use the prize:

- 9. Students must provide Sasfin Wealth with proof of their registration at a tertiary institution for the year in which they would like to claim the prize.
- 10. Students must be older than 18 years to claim the prize.
